The index is designed to represent the performance of 50 stocks from MSCI EMU Index, that are selected based on their 3-month Annualized Traded Value (ATV), and based on the MSCI ESG Screened Indexes and the MSCI ESG Universal Indexes methodologies. Securities are weighted as per the MSCI ESG Universal Indexes methodology, and the top 50 securities based on weight are selected as final constituents of the index.




