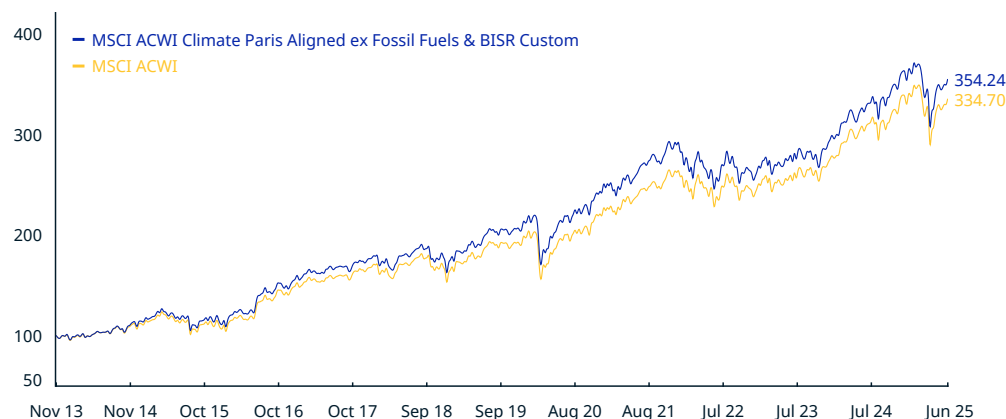


MSCI ACWI Climate Paris Aligned ex Fossil Fuels & BISR Custom Index (GBP)

The MSCI ACWI Climate Paris Aligned ex Fossil Fuels & BISR Custom Index ("the Index") is designed to follow the MSCI Climate Paris Aligned Indexes Methodology while also excluding all companies in the following categories, based on custom criteria: United Nations Global Compact principles compliance, Controversial weapons, nuclear weapons, civilian firearms, and conventional weapons, Fossil Fuel Reserves, Extraction and Power Generation, Adult entertainment, alcohol, gambling, recreational cannabis, palm oil and For Profit Prisons and Sustainable Development Goals Alignment (goals 6, 7, 12, 13, 14, and 15) .

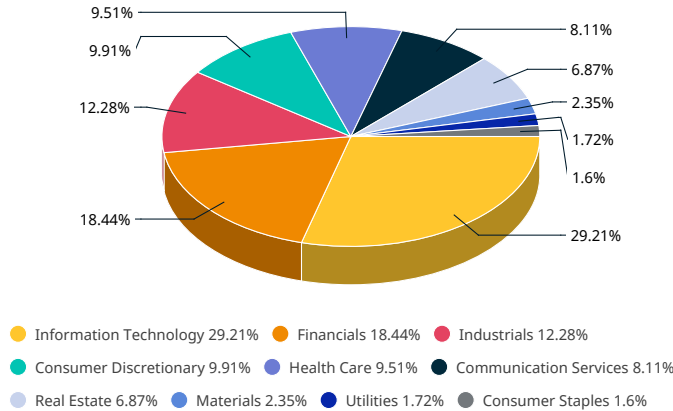

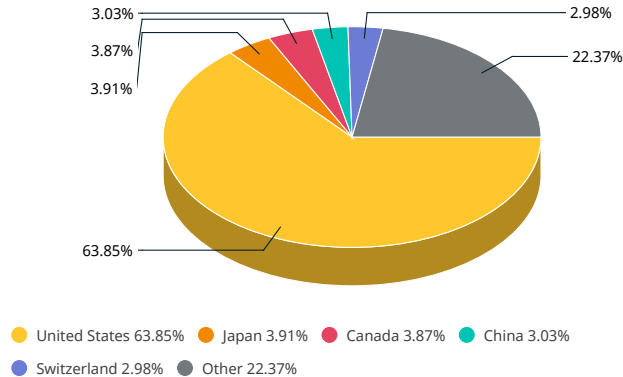
