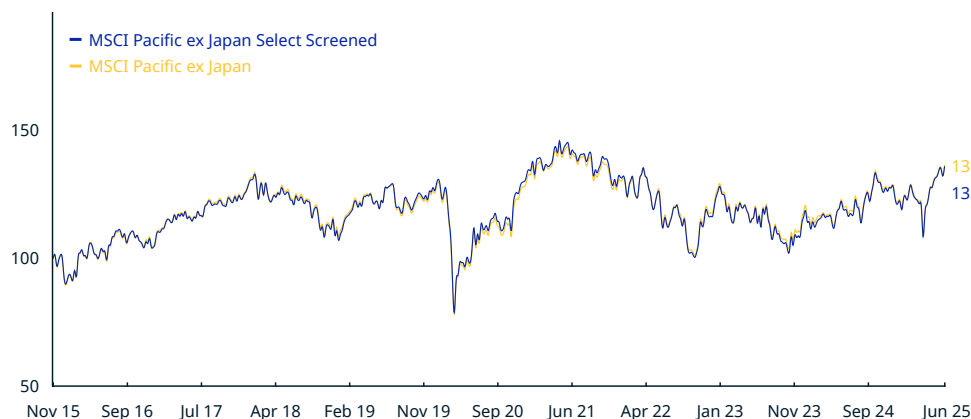


# MSCI Pacific ex Japan Select Screened Index (USD)

The MSCI Pacific ex Japan Select Screened Index is based on the MSCI World Index, its parent index, and includes large and mid-cap securities across 4 of 5 Developed Markets (DM)\* countries in the Pacific region (excluding Japan).. The index excludes companies from the parent index that are associated with conventional, controversial, civilian and nuclear weapons and tobacco, that are assigned an MSCI ESG Rating of 'CCC', that derive revenues from thermal coal and oil sands extraction or that are not in compliance with the United Nations Global Compact principles.

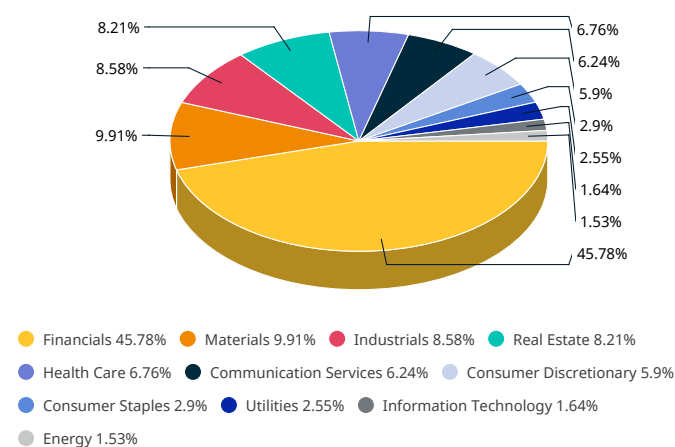

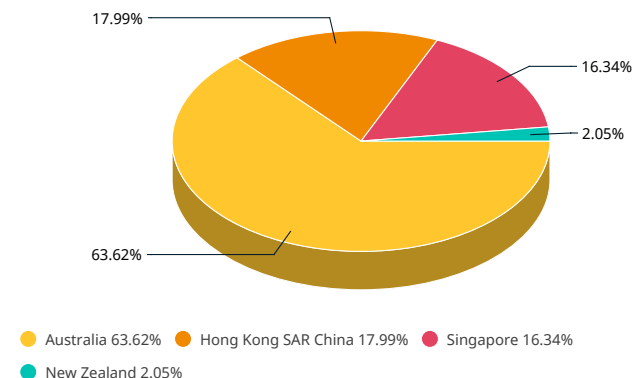
