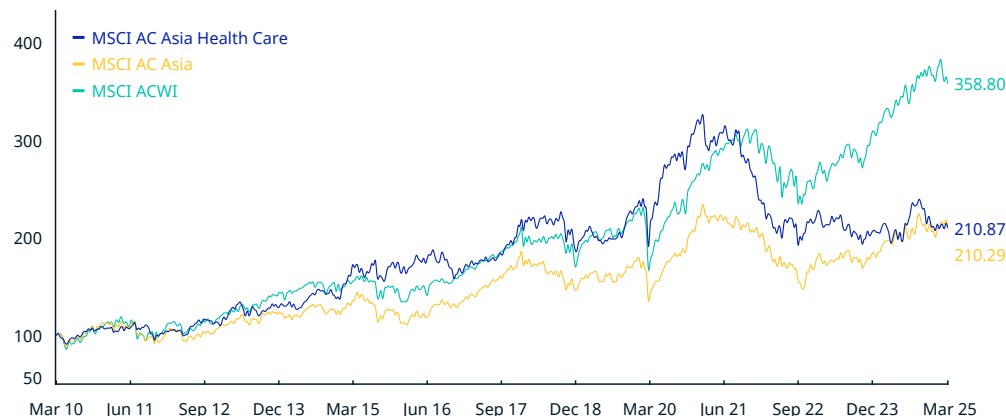


# MSCI AC Asia Health Care Index (USD)

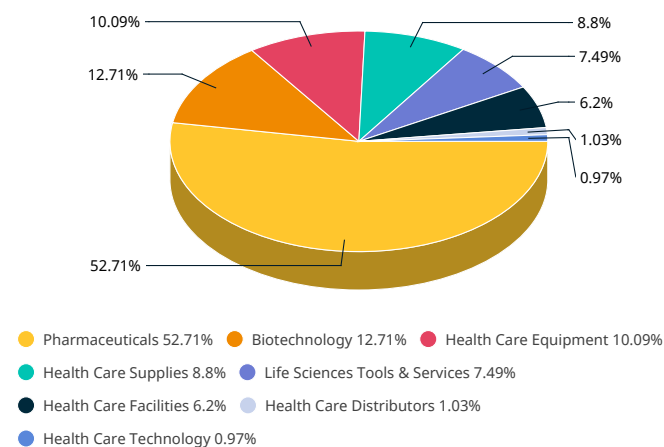

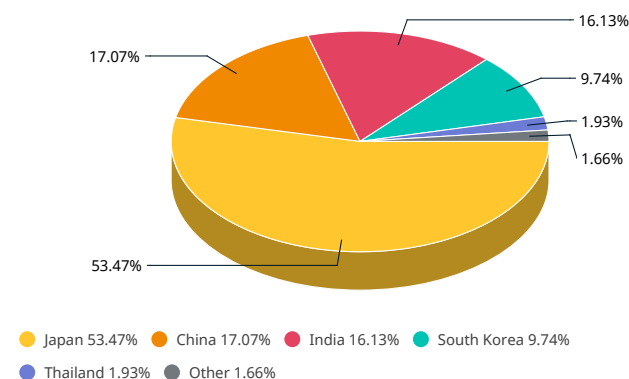
