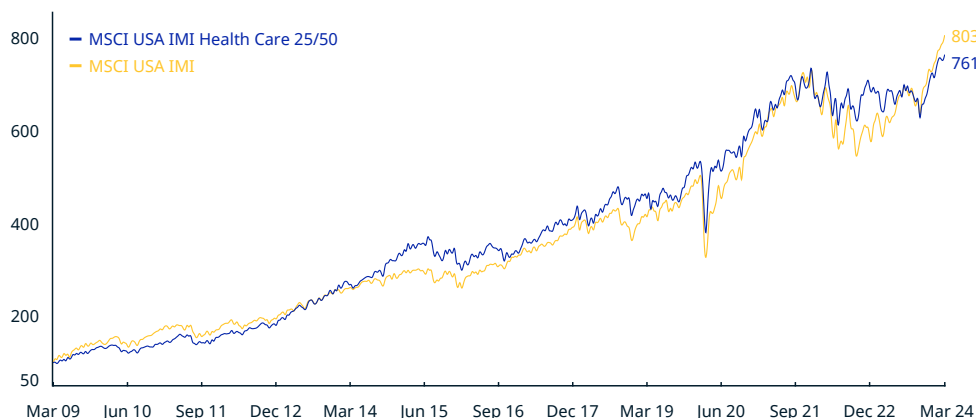


MSCI USA IMI Health Care 25/50 Index (USD)

All securities in the index are classified in the Health Care sector according to the Global Industry Classification Standard (GICS®). 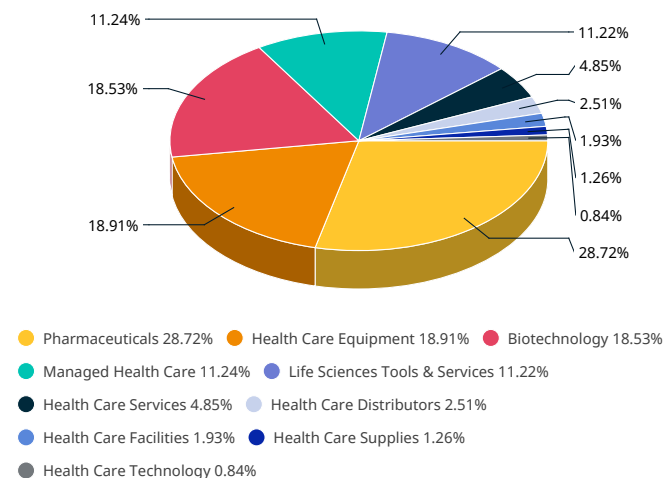
