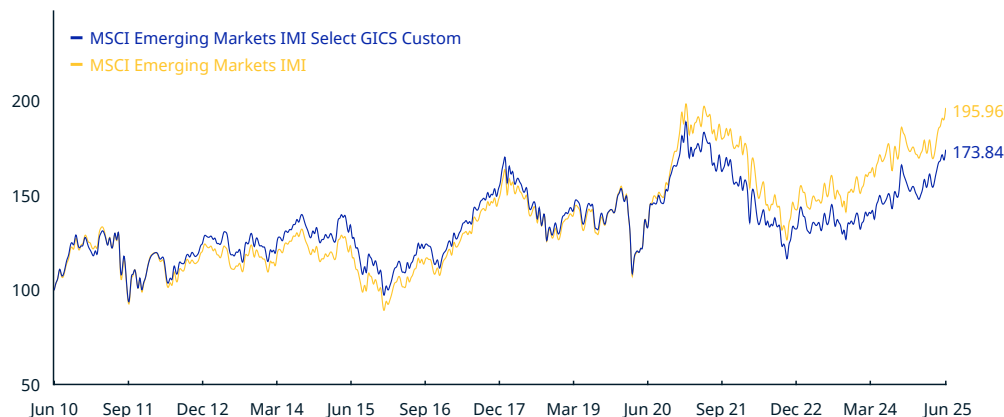


# MSCI Emerging Markets IMI Select GICS Custom Index (USD)

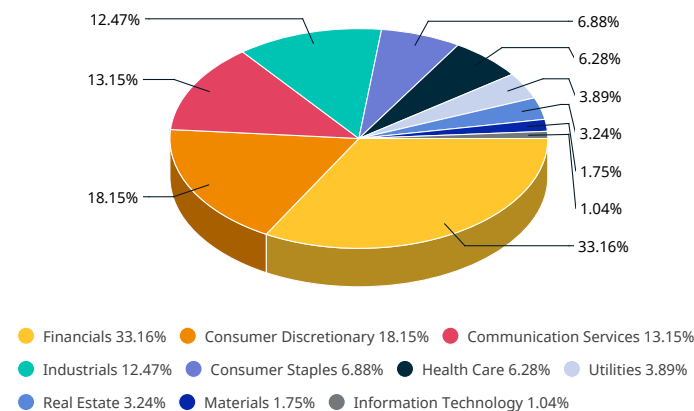

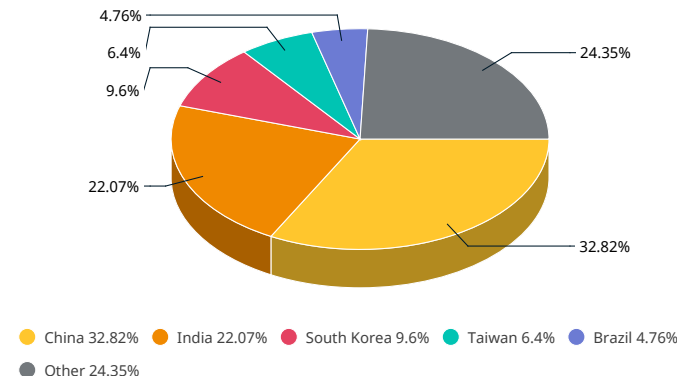
