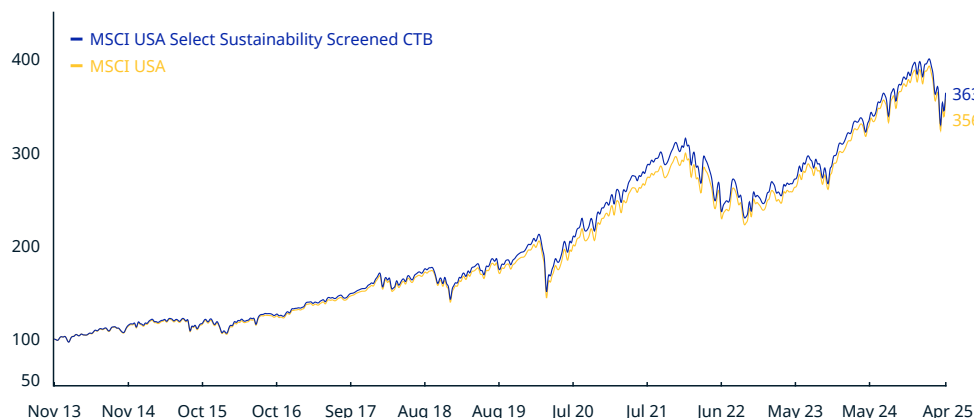


# MSCI USA Select Sustainability Screened CTB Index (USD)

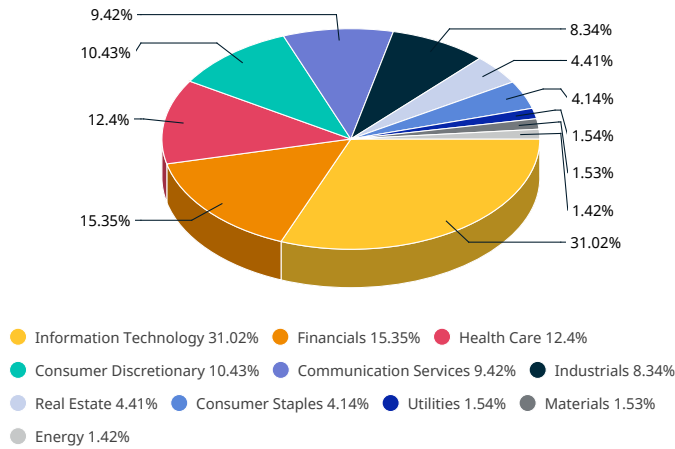

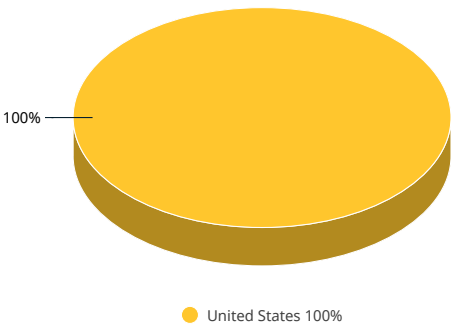
