
MSCI EMU Climate Change ESG Select 4% Decrement Index (EUR)

The MSCI EMU Climate Change ESG Select 4% Decrement Index is based on the MSCI EMU Climate Change ESG Select Index, its parent index, and includes large and mid-cap segments across 10 developed markets (DM) countries* in the EMU. The index is constructed based on the MSCI Climate Change Indexes methodology while incorporating additional business exclusion screens including Nuclear Weapons, Tobacco, Thermal Coal, Nuclear Power, Conventional Weapons and Unconventional Oil & Gas. Additionally, companies that not in compliance with the United Nations Global Compact principles are also excluded from the index. Only companies rated B and above are eligible for inclusion in the index. The index applies a constant markdown ('synthetic dividend') of 4% on an annual basis, expressed as a percentage of performance.




