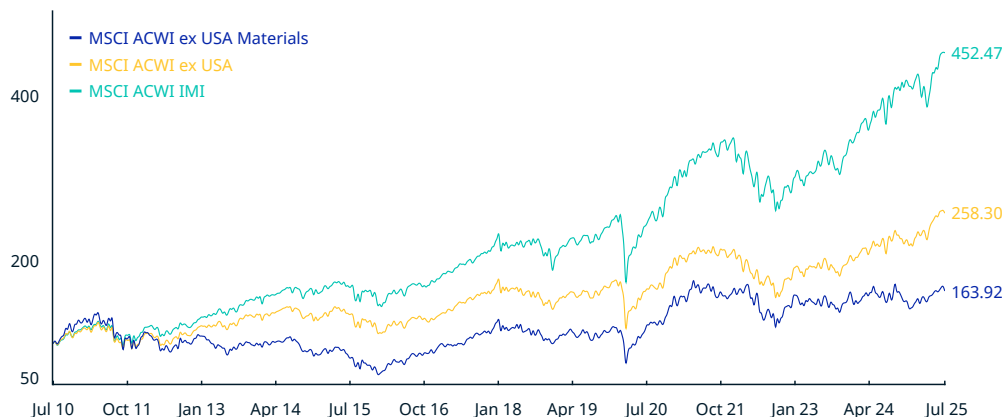


MSCI ACWI ex USA Materials Index (USD)

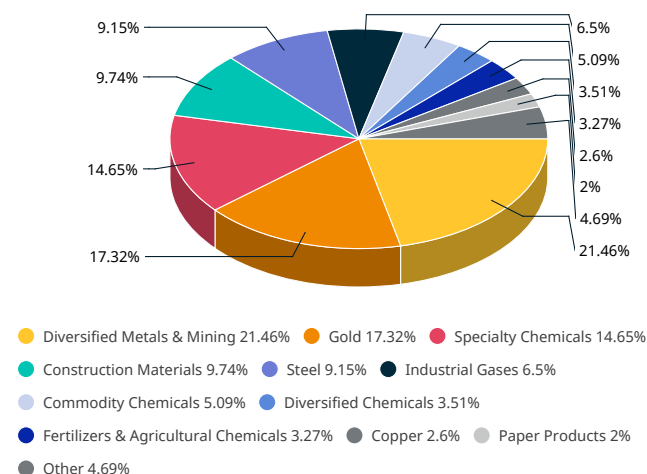

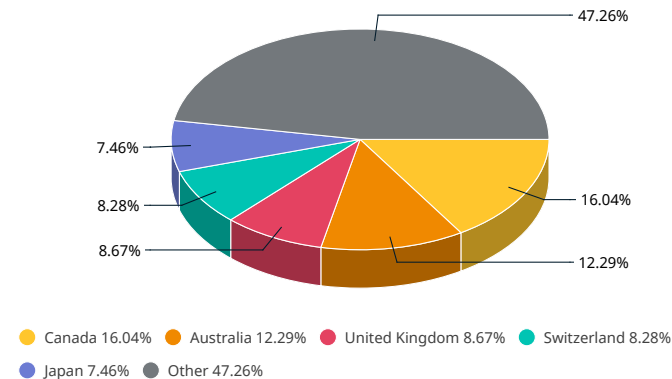
