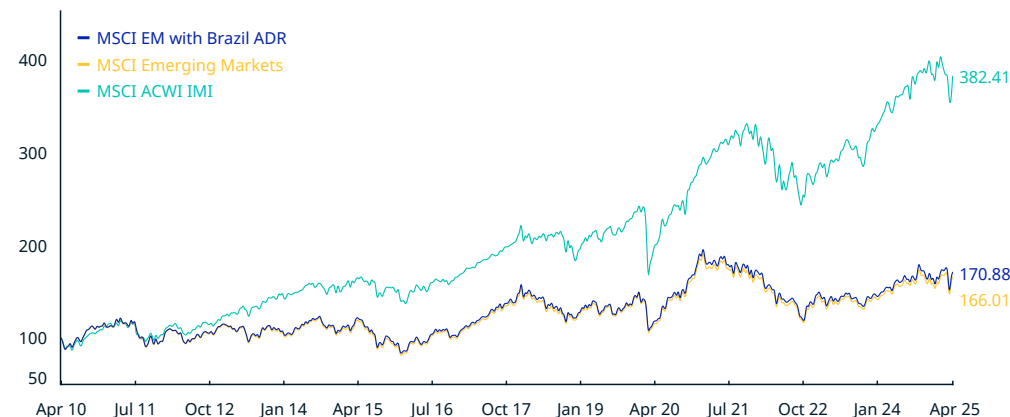


MSCI EM with Brazil ADR Index (USD)

The **MSCI Emerging Markets (EM) with Brazil ADR Index** captures large and mid cap representation across 24 Emerging Markets countries*. Index constituents for Brazil are composed of liquid American Depository Receipts (ADR). With 1,180 constituents, the index covers approximately 85% of the free float-adjusted market capitalization in each country.

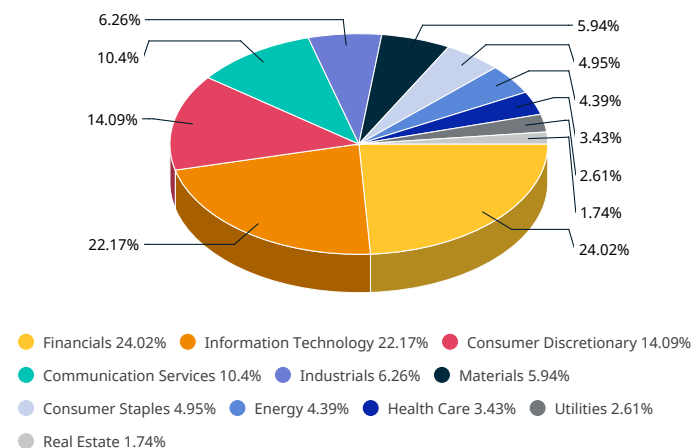

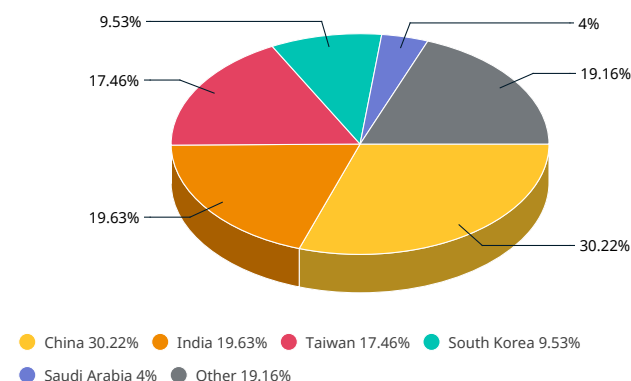
