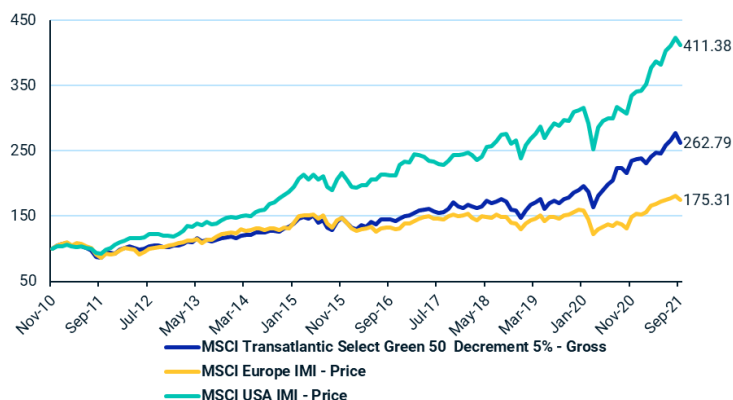


MSCI Transatlantic Select Green 50 Decrement 5% Index (EUR)

The MSCI Transatlantic Select Green 50 Decrement 5% (Gross) Index is based on securities from MSCI USA IMI Index and MSCI Europe IMI Index, and includes large, mid and small-cap securities across USA and 15 Develop Market (DM) countries* in Europe. The index aims to represent the performance of the largest 25 stocks by free-float market capitalization from each of USA and Europe that offer products and services that contribute to an environmentally sustainable economy through efficient use of limited global natural resources. The index also excludes companies that are involved in the production of controversial, nuclear or conventional weapons, as well as those that are involved in environmental and ESG controversies. The index aims to apply a constant markdown ('synthetic dividend') of 5% on the gross total return variant on an annual basis, expressed as a percentage of performance.

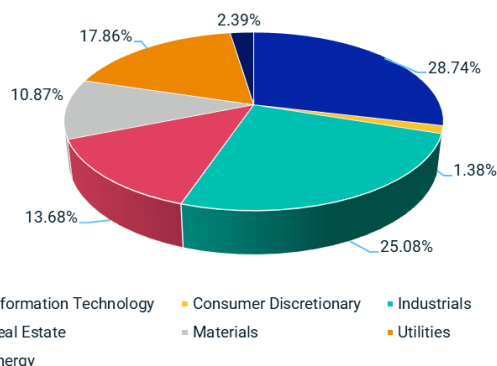

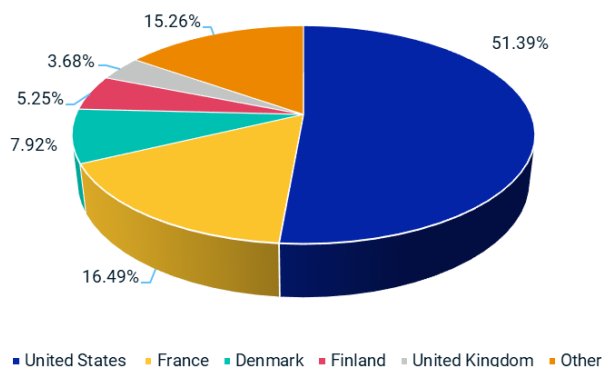
