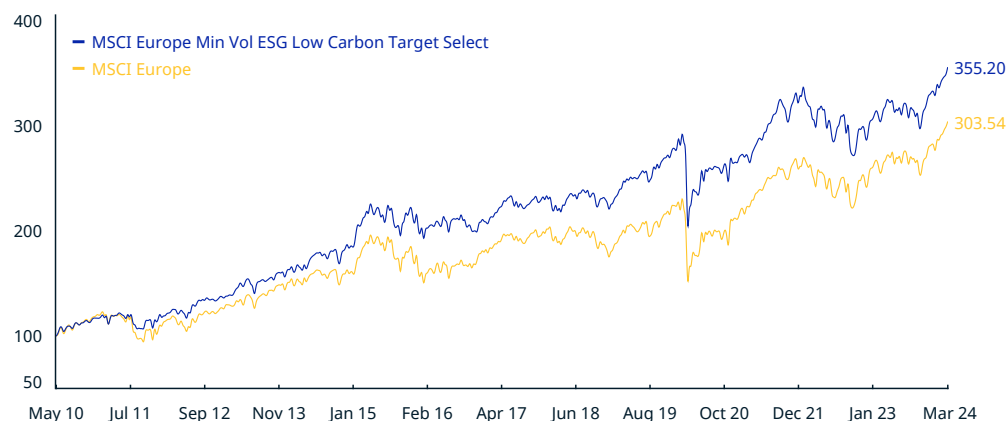


MSCI Europe Minimum Volatility ESG Low Carbon Target Select Index (EUR)

The MSCI Europe Minimum Volatility ESG Low Carbon Target Select Index is based on MSCI Europe Index, its parent index, and includes large and mid-cap securities across 10 Developed Markets (DM) countries* in Europe. The index is designed to represent the performance of a strategy that seeks systematic integration of environmental, social and governance (ESG) norms while minimizing ex-ante total risk.

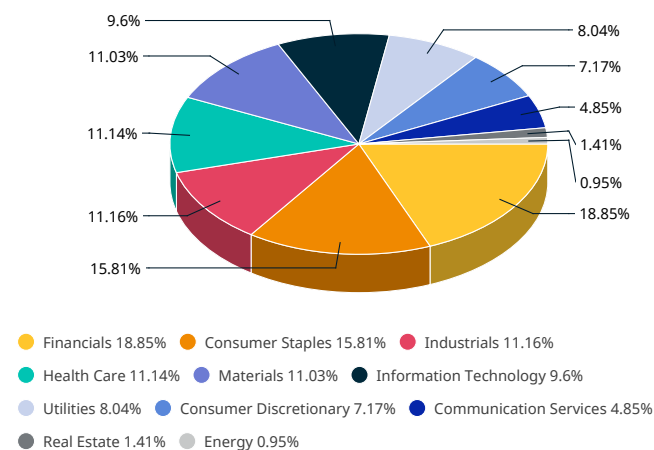

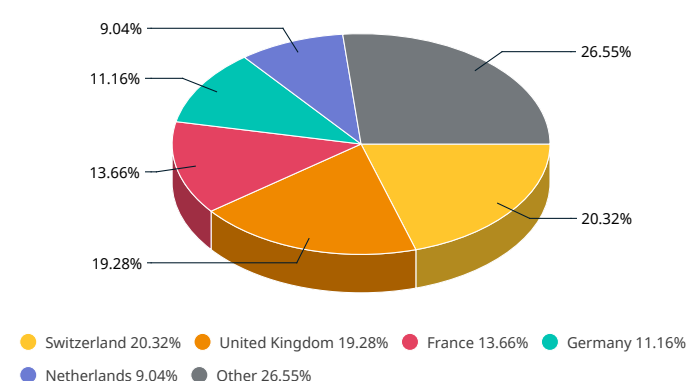
