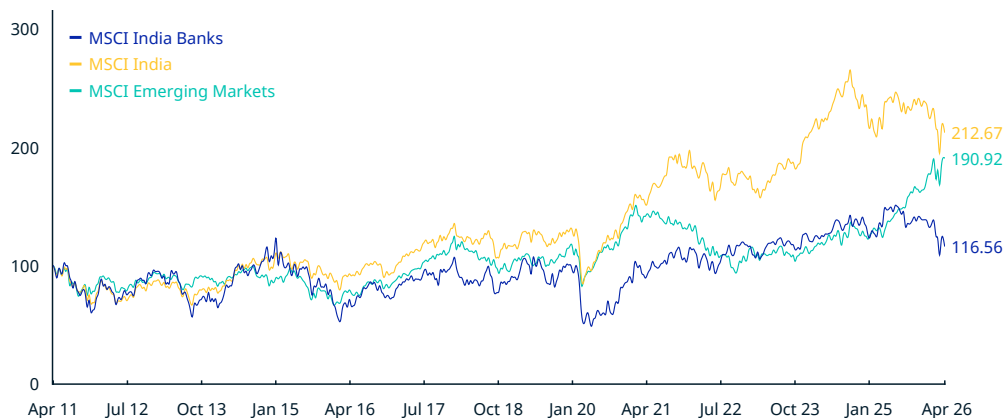


# MSCI India Banks Index (USD)

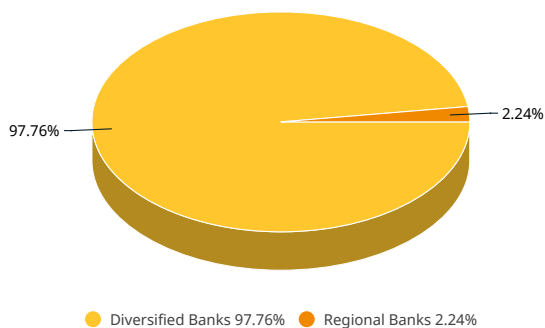
