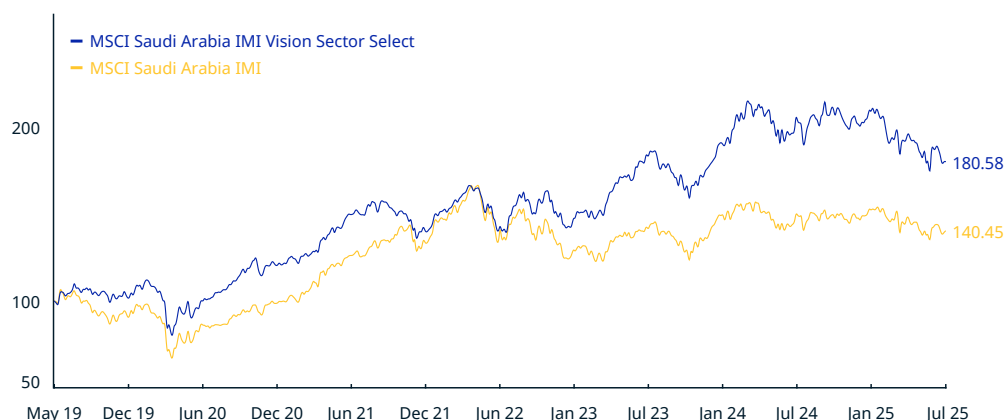


# MSCI Saudi Arabia IMI Vision Sector Select Index (USD)

The MSCI Saudi Arabia IMI Vision Sector Select Index (the "Index") aims to reflect the performance of securities belonging to the GICS Sub-industries outlined under section 2 according to the Global Industry Classification Standard (GICS®) in the MSCI Saudi Arabia Investable Market Index. The index is constructed based on the MSCI Global Investable Market Indexes methodology. The weight of securities in the index is capped in accordance with the MSCI 10/40 Indexes methodology. The Index also rebalances on an "as needed" basis. This means that the Index is rebalanced at the end of any day on which the MSCI 10/40 Indexes methodology constraints are breached.

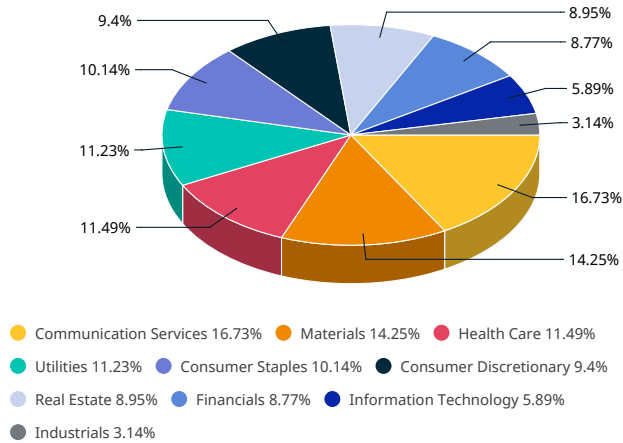
