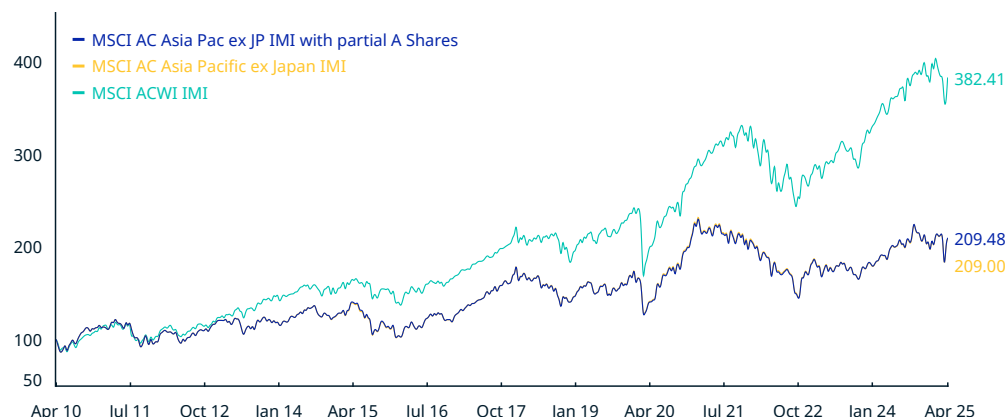


# MSCI AC Asia Pacific ex Japan IMI with partial A Shares Index (USD)

The MSCI AC Asia Pacific ex Japan IMI with partial A Shares Index captures large, mid and small cap representation across 4 of 5 Developed Markets countries\* (excluding Japan) and 9 Emerging Markets countries\* in the Asia Pacific region. With 5,122 constituents, the index covers approximately 99% of the free float-adjusted market capitalization in each country. The index reflects the effect of a potential 5% partial inclusion of China A-shares into the MSCI Emerging Markets Index as outlined in the "Index Inclusion Roadmap for China A-Shares in the MSCI Emerging Markets Index" consultation proposal as part of MSCI's Annual Market Classification Review.

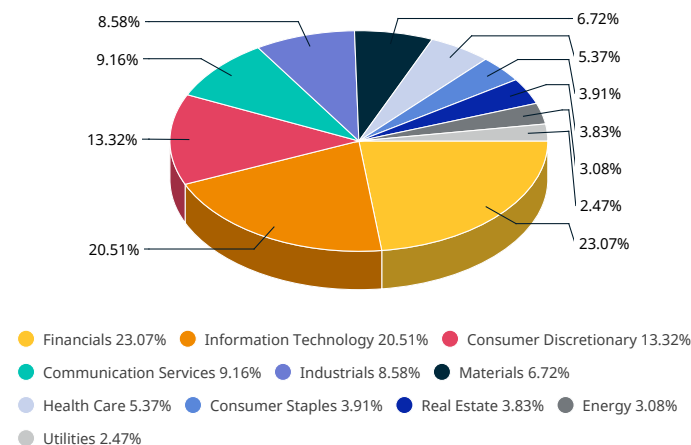

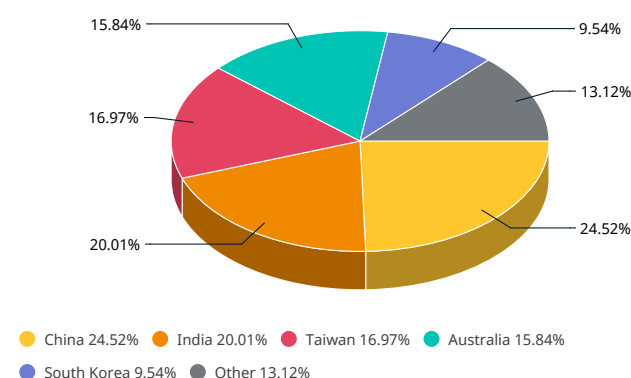
