
MSCI ACWI with EUR and GBP 100% Hedged to USD Index (USD)

The MSCI ACWI with EUR and GBP 100% Hedged to USD Index represents a close estimation of the performance that can be achieved by hedging the EUR and GBP currency exposures of its parent index, the MSCI ACWI Index, to the USD, the "home" currency for the hedged index. The EUR and GBP exposures are 100% hedged to the USD by selling the two foreign currencies forward at the one-month Forward rate. The parent index is composed of large and mid-cap stocks across 23 Developed Markets (DM) countries and 24 Emerging Markets (EM) countries*.


