

# MSCI Emerging Markets with 18% India Capped Index (USD)

The MSCI Emerging Markets with 18% India Capped Index is based on the MSCI Emerging markets Index which captures large and mid cap representation across 24 Emerging Markets (EM) countries\*, while capping the aggregated weight of the securities with an MSCI Country of Classification of India to 18% at each beginning of the month. The weight of securities in the index is capped in accordance with the MSCI Capped Indexes methodology.

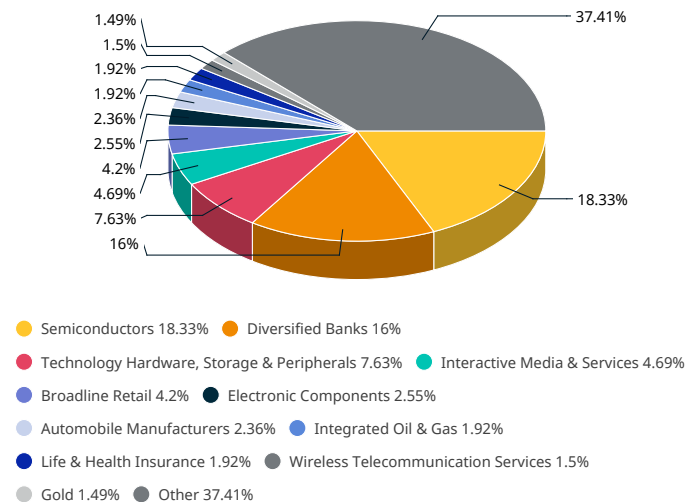

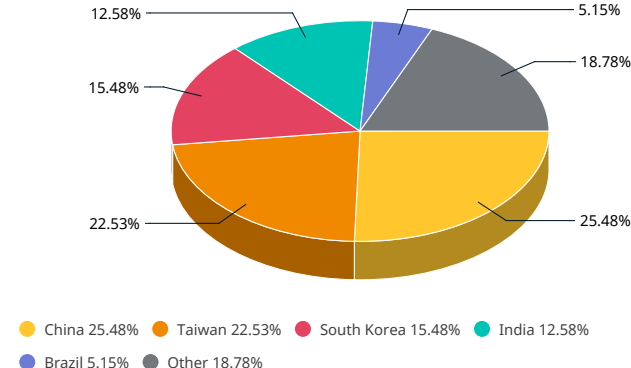
