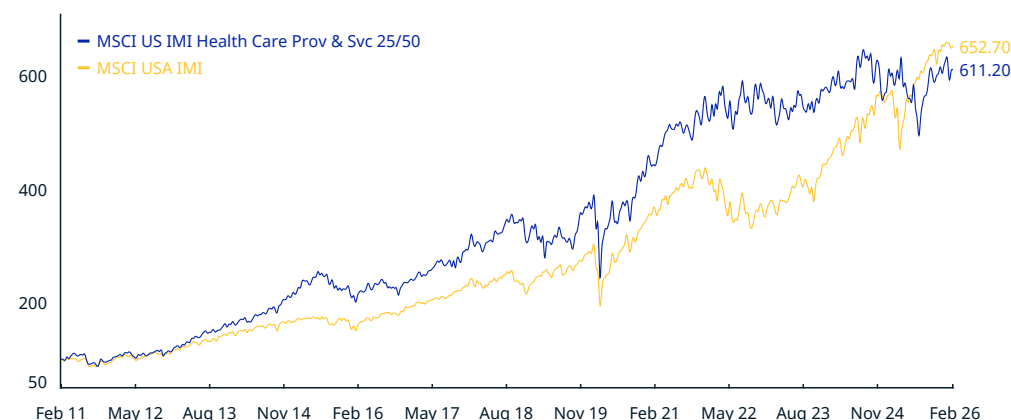


# MSCI US IMI Health Care Providers and Services 25/50 Index (USD)

The **MSCI US IMI Health Care Providers & Services 25/50 Index** is designed to capture the large, mid and small cap segments of the US equity universe. All securities in the index are classified in the Providers & Services Industry (within the Health Care sector) as per the Global Industry Classification Standard (GICS®). The index also applies certain investment limits to help ensure diversification limits that are imposed on regulated investment companies, or RICs, under the current US Internal Revenue Code.

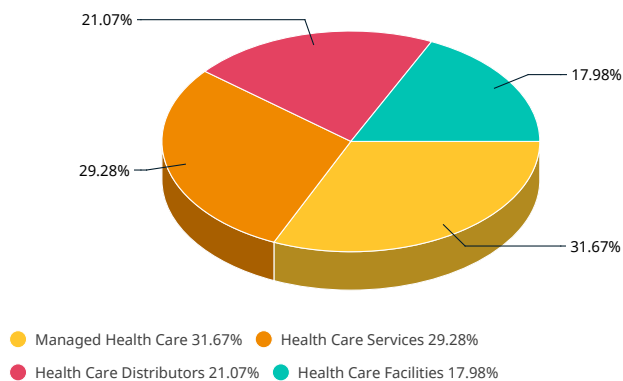
