


MSCI Brazil Custom Infrastructure Index (USD)

The MSCI Brazil Custom Infrastructure Index is based on its parent index, MSCI Brazil Index, and covers large and mid cap securities. All index constituents are categorized in the Industry Groups: Energy, Materials, Capital Goods, Transportation, Real Estate, Technology Hardware & Equipment, Telecommunication Service, Utilities and Industry - Household Durables, according to the Global Industry Classification Standard (GICS®).


