The Index also aims to maintain risk and return characteristics similar to those of its underlying market capitalization weighted index (the MSCI India Index). Additionally, the index aims to exceed the minimum technical requirements laid out for EU Climate Transition Benchmarks in the EU Delegated Acts.

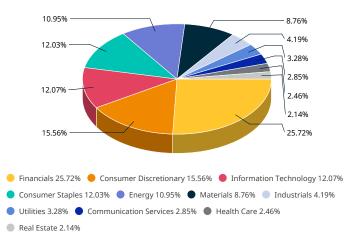
