

MSCI Announces European Property Investment Award Winners

London – November 22, 2016 - MSCI Inc. (NYSE: MSCI), a leading provider of portfolio construction and risk management tools for global investors, is pleased to announce this year’s winners of the 18th MSCI European Property Investment Awards. These annual awards recognize European funds that out-performed in each of most European countries during the three years to December 2015.

Malcolm Hunt, Executive Director, MSCI said, “These prizes award the best three-year out-performing balanced and specialist funds in each country. Out-performing over a three-year period is an outstanding achievement; many congratulations to each management team involved.”

Determined by MSCI’s standardized performance measurement procedures, the awards recognize independently verified investment performance by pension and life funds, pooled funds, property investment companies and other professionally managed real estate portfolios across the 580 eligible European portfolios.

To be eligible for the annual awards, all funds were measured by MSCI’s Real Estate Portfolio Analysis Service, which provides investors with an independent audit of returns against a relevant market or sector benchmark.

In each country, the awards identify consistently measured real estate investment performance across two categories:

- **Balanced:** highest total return relative to the real estate All Property benchmark annualised over 3 years to December 2015
- **Specialist:** highest total return relative to the real estate sector benchmark annualised over 3 years to December 2015

Additionally, two additional awards are given to:

- The best performing pan-European balanced fund, based on the highest 3-year NAV-level performance
- The best European fund with the highest long-term risk-adjusted return
