Conclusion of MSCI consultation on the proposal for MSCI Global Real Asset Classification Standards (GRACS)

London, November 2024: MSCI Inc. This aims to establish a single global hierarchy and classification standard to promote transparency and efficiency across the industry.

The MSCI GRACS structure consists of 12 sectors, 43 sub-sectors and 175 property types.

MSCI GRACS will be implemented in all new product developments. MSCI will issue further announcements with a roadmap for MSCI GRACS adoption in existing Real Assets products by early 2025.
