IPD HUNGARY ANNUAL PROPERTY INDEX

CHANGE IN INDEX COMPOSITION

Frankfurt, March 2018: MSCI announces a change in the composition of the IPD Hungary Annual Property Index for December 2017. The December 2017 results exclude information on one fund which have not submitted data. The historical data for the properties in this fund will remain in the index history up to December 2016.

The above changes result in a decrease of 14.63% in the overall Capital Value of the Index. Changes in the composition of the index can be seen in the table below, which shows the change in sector weightings for December 2016 by property type. This has the largest impact on the sector weight for Industrial and Office with a decrease of 1090 basis points and increase of 620 basis points, respectively.
