CHANGE IN INDEX COMPOSITION

Frankfurt, March 2018: MSCI announces a change in the composition of the IPD Wüest & Partner Annual Property Index for December 2017. The index now includes three new contributing funds.

The above changes result in an increase of 5.2% in the overall Capital Value of the Index. Changes in the composition of the index can be seen in the table below, which shows the change in sector weightings for December 2016 by property type. This has the largest impact on the sector weight for Office and Retail with an increase of 40 basis points and decrease of 30 basis points, respectively.
