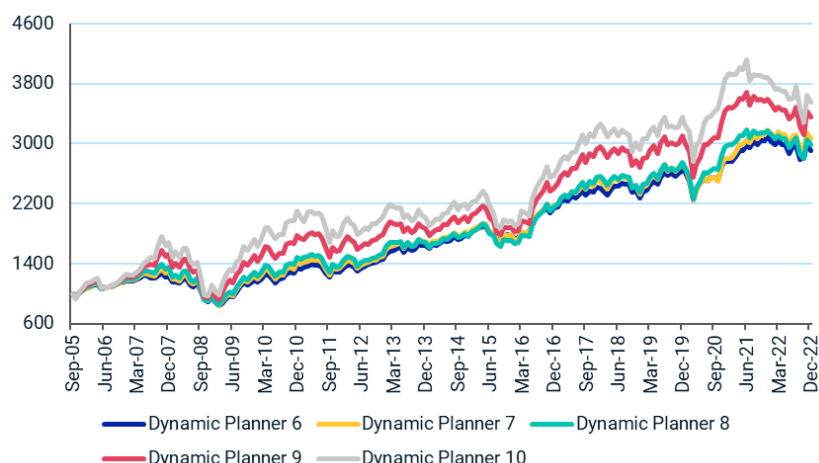


MSCI Multi-Asset Indexes: Dynamic Planner Indexes 6-10 (GBP)

Dynamic Planner (DP) was launched in 2003 and today is one of the UK's most-widely used risk profiling and asset allocation investment processes supporting thousands of financial advisers and planners. Dynamic Planner's asset and risk model has produced a set of model portfolios at an asset class level, optimized to deliver good returns for one of ten investor risk levels from low-risk to high-risk. MSCI has developed a series of ten indexes designed to represent the risk and return characteristics of these strategies by targeting a pre-determined target risk range.

Index methodology

The Dynamic Planner Indexes (the "Indexes") are a combination of ICE fixed income and MSCI Indexes. These custom indexes are produced by MSCI, with component index weights provided by Distribution Technology Ltd (DT). The Indexes are available in net variant calculated as per the MSCI Net Daily Total Return (DTR) Index methodology respectively described in the MSCI Index Calculation Methodology.

The Dynamic Planner Indexes are rebalanced monthly on the first business day of the month. The weights of component indexes constituting the Dynamic Planner Indexes are provided by DT which are reviewed by DT on a quarterly basis for each of the ten indexes.
