CHANGE IN INDEX COMPOSITION

London, 2019: MSCI announces changes in the composition of the MSCI PAN-EUROPEAN QUARTERLY PROPERTY FUND INDEX (UNFROZEN) for September 2019. The index includes one new contributing fund as of September 2019.

Overall, the above changes result in an increase of 6.0% in the Net Asset Value of the index. The impact on the index can be seen in the table below, which shows the sector weight variations for September 2019.
