

MSCI FRANCE CAPITAL GROWTH ANNUAL PROPERTY INDEX (UNFROZEN)

MSCI preview indicates a -2.4% Annual Office Capital Growth for 2022

Paris – January 31, 2023 – MSCI Inc. (NYSE: MSCI), a leading provider of research-based indexes and analytics, today provided a preview into the performance of real estate investments in France for 2022. Calculations show that the Office Capital Growth level in France for 2022 was -2.4% on standing investments.

The preliminary result for Capital Growth covers a sample of 1,568 properties within 33 funds, for a value of €80 billion, hence around 39% of the value within the MSCI France Annual Property Index. Please note that given the limited size of the sample, the preliminary result may deviate from the final result.

The official growth rate of the MSCI France Annual Property Index will be confirmed with the release on March 24, 2023 at 16:00 hours CET.

Carine Dassé, Executive Director, MSCI, commented: "MSCI France Capital Growth Preview provides a first indication of the 2022 real estate performance, two months before the publication of the annual Index. In 2022, the office capital growth dropped to -2.4% but with strong heterogeneity between assets and locations, Paris CBD offices still recorded a marginal positive capital growth. Residential resisted at 1.1% while retail capital values continued to decline."
