

MSCI France Biannual Property Index (Unfrozen)

March 2019

Change in Index Composition

Paris, March 2019: MSCI announces a change in the composition of the MSCI France Biannual Property Index (Unfrozen) for December 2018. The December 2018 index includes two new funds and also includes additional historic data submission for particular index participants.

Overall, the above changes result in an increase of 9.6% in the Capital Value of the Index. Changes in the composition of the index can be seen in the table below, which shows the change for June 2018. The change has the largest impact on the office sector weight with an increase of 430 basis points.
