Introduction

The COVID-19 pandemic may be viewed as impacting financial markets in two waves. The first wave commenced with the outbreak in China in early January 2020 and the second wave began with the global outbreak in late February 2020.


In this daily report, we compare how MSCI factors and industry groups indexes have performed relative to the benchmarks during these two waves of the COVID-19 pandemic commencing Jan. 10 and Feb. 21, 2020, with a focus on the markets below.*

Region / Country	Benchmark Index Description
Asia ex JP	The MSCI AC Asia ex Japan Index reflects large- and mid-cap representation across two of three developed market countries (excluding Japan) and nine emerging market countries in Asia
China	The MSCI China Index reflects large- and mid-cap representation across China A shares, H shares, B shares, Red chips, P chips and foreign listings (e.g. ADRs)
China A	The MSCI China A Index measures large- and mid-cap representation of local listed China A shares
Europe	The MSCI Europe Index represents the performance of large- and mid-cap equities across 15 developed countries in Europe
USA	The MSCI USA Index is designed to measure the performance of the large- and mid-cap segments of US market






Factor indexes: Minimum Volatility






Factor indexes: High Dividend Yield






















MSCI Food, Beverage & Tobacco relative performance






MSCI Insurance relative performance



MSCI Materials relative performance










MSCI Retailing relative performance







MSCI Telecommunication Services relative performance


