The Bloomberg MSCI 1-5 Year US Aggregate ESG Select Index is a fixed-rate, investment grade bond benchmark that follows the rules of the Bloomberg US Aggregate Index and applies additional sector, maturity, and ESG criteria for security eligibility. In addition, treasury, securitized, and class 2 government-related (agency, local authority, sovereign, supranational) and class 2 corporate (industrial, utility, and financial) sectors are weighted to match the individual sector exposures of the pre-screened index. The index was launched in May 2023, with history available back to January 2021.
