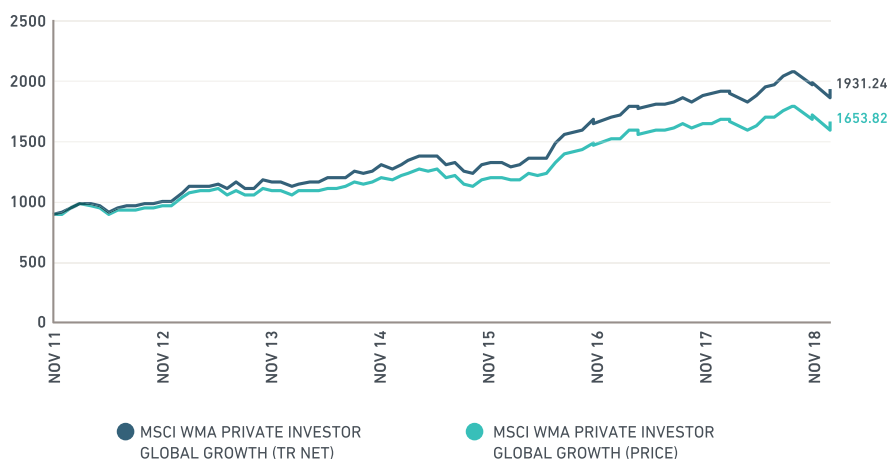


MSCI WMA PRIVATE INVESTOR GLOBAL GROWTH INDEX
