

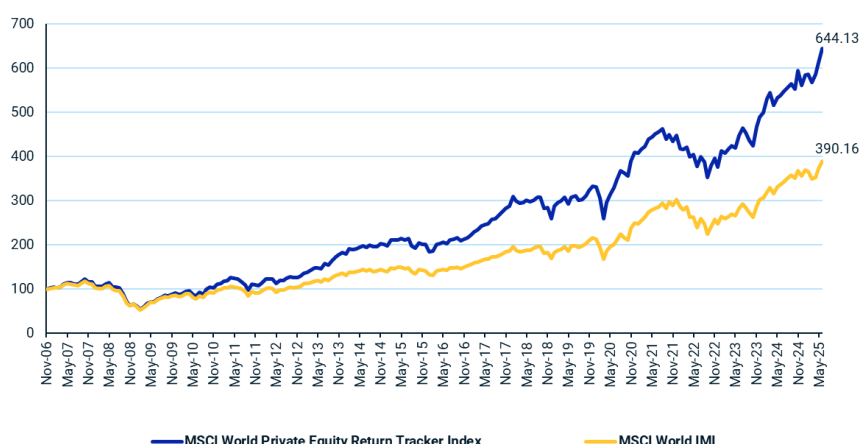
# MSCI World Private Equity Return Tracker Index

These exposures are informed by private company fundamental data sourced from the MSCI Private Capital Universe. The MSCI Private Capital Universe is a comprehensive proprietary database of private investments which encompasses a vast collection of data on private capital funds and their underlying holdings, including private equity.

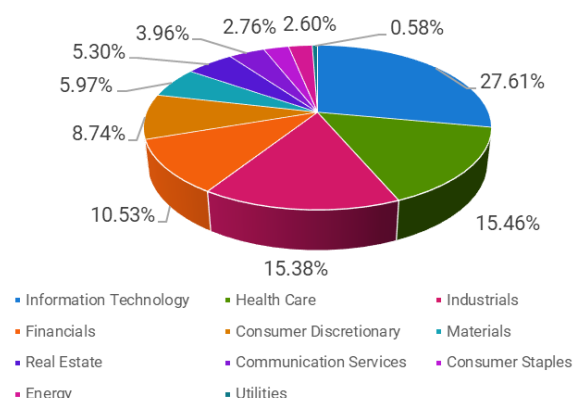

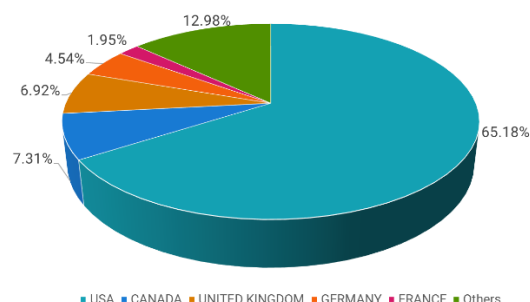
