1. Introduction

The MSCI ACWI IMI Smart Security & Defense Index (the 'Index') aims to represent the performance of a set of companies that are associated with the development of new products and services focused on the Smart Security & Defense¹ value chain.

2. Constructing the Index

The Index is constructed by selecting stocks from the MSCI ACWI Investable Market Index (IMI) (the 'Parent Index'²) based on rules explained in the following sections.

The Index selects companies which are assessed to have high exposure to business activities such as –

- Cybersecurity
- Future Defense and Smart Borders

MSCI may seek input from outside market experts on the ongoing evolution of the themes underlying the Index. However, such input is advisory only in nature. MSCI alone decides whether to use such input at all or to what extent. Receipt of such input, like any other feedback on MSCI indexes, may or may not lead to a change to the Index or Index methodology.

2.1 Selected Universe

Stocks in the Parent Index that have a Relevance Score³ of 25% or more are included in the Selected Universe.

2.1.1 GICS^{®4} sector and sub industry filtering

Stocks mapped to the following GICS sub industries are excluded from the Selected Universe.

2.2 Weighting scheme

Stocks included in the Index are weighted by the product of Relevance Score and their weight in Parent Index. The weights are then normalized to 100%. Additionally, constituent weights are capped at the issuer level to mitigate concentration risk in the Index. The issuer weight in the Index is capped at 5%. This issuer capping is not applied between two rebalancing dates.



3. Maintaining the Index

3.1 Semi-Annual Index Reviews

The Index is reviewed on a Semi-Annual basis in May and November to coincide with the May and November Index Reviews of the Parent Index, and the changes are implemented at the end of May and November. In general, the pro forma Index is announced nine business days before the effective date.

During the Semi-Annual Index Review, the Selected Universe is updated.

In general, MSCI uses Relevance Score data as of two business days prior to the rebalancing date for the Semi-Annual Index Review.

3.2 Ongoing Event-Related Changes

The general treatment of corporate events in the Index aims to minimize turnover outside of Index Reviews. The methodology aims to appropriately represent an investor's participation in an event based on relevant deal terms and pre-event weighting of the Index constituents that are involved. Further, changes in Index market capitalization that occur as a result of corporate event implementation will be offset by a corresponding change in the Variable Weighting Factor (VWF) of the constituent.

The following section briefly describes the treatment of common corporate events within the index.

No new securities will be added (except where noted below) to the index between Index Reviews. Parent Index deletions will be reflected simultaneously.

**EVENT TYPE****EVENT DETAILS****New additions to the Parent Index**

A new security added to the Parent Index (such as IPO and other early inclusions) will not be added to the index.

Spin-Offs

Securities created as a result of the spin-off of an existing index constituent will not be added to the Index at the time of the event implementation.

Merger/Acquisition

If an existing Index constituent is acquired by a non-Index constituent, the existing constituent will be deleted from the Index and the acquiring non-constituent will not be added to the Index.

Changes in Security Characteristics

A security will continue to be an Index constituent if there are changes in characteristics (country, sector, size segment, etc.) Reevaluation for continued inclusion in the Index will occur at the subsequent Index Review.
