1 Introduction

The MSCI EMU 4% Decrement Index, MSCI USA 4% Decrement Index, MSCI Emerging Markets 4% Decrement Index, MSCI ACWI 4% Decrement Index, MSCI World 4% Decrement Index, (herein, “MSCI Global 4% Decrement Indexes”) are constructed by applying the MSCI Global Investable Market Indexes Methodology¹. A constant markdown (‘synthetic dividend’) is subsequently applied on a daily basis, expressed as a percentage of performance.

2 Constructing the MSCI Global 4% Decrement Indexes

2.1 ELIGIBLE UNIVERSE

The eligible universe for MSCI Global 4% Decrement Indexes includes all the constituents of their respective MSCI parent index (the “Parent Index”), as shown in the table below.

2.2 APPLYING THE MSCI DECREMENT INDEXES METHODOLOGY

A constant markdown (‘synthetic dividend’) is applied on the respective Parent Index levels on a daily basis, expressed as a percentage of performance, to construct MSCI 4% Decrement Indexes.
