The MSCI Hedge Fund Composite IndexSM, an equal weighted index, posted a 0.28% return for the month of July underperforming the MSCI World Equity IndexSM which gained 1.92% and outperforming the MSCI World Sovereign Debt IndexSM which lost -2.97%. The MSCI Hedge Fund Database has grown to over 1,550 hedge funds. More than 99% of funds reported performance as of July's index calculation.

With equity markets rising, it is not surprising that Security Selection funds were the best performer in July with a gain of 1.41% bringing its year to date return to 9.76%. Long Bias was the best performing investment process within Security Selection posting a 2.28% in contrast with Short Bias which was down -2.57%. By market cap focus, Security Selection Small Cap funds gained 3.84% outperforming Security Selection Mid and Large Cap funds which returned 0.62%. This is consistent with the performance of the relevant U.S. equity market indices. The MSCI U.S. Small Cap 1750 Index rose 5.42% in July while the MSCI U.S. Prime Market 750 Index, comprised of mid-to-large cap stocks, rose 1.84%. The overall MSCI U.S. Investable Market 2500 Index gained 2.20% in July.

Consistent with June, Directional Trading was the worst performer in July at -1.58% compared with June's -1.56% loss. Systematic Trading, again, had the greatest impact with a -2.44% return in July. On a year to date basis, Directional Trading is up 6.82% while Systematic Trading has gained 6.06%. Directional Traders comprise more than 50% of the MSCI Hedge Fund Diversified IndexSM, an asset class index, largely contributing to its -0.63% July performance. Directional Traders have the highest three year standard deviation at 8.97%. Relative Value funds have continued to perform consistently with a low three year standard deviation of 1.90%, lower than any other process group. The MSCI Relative Value IndexSM lost -0.53% in July bringing its year to date return to 4.75%. Although Arbitrage was the best performer over the past year within Relative Value with a 11.02% return, it is down for the month losing -0.61%.


This month, Specialist Credit returned 0.90%, bringing its year to date performance to 12.55%. Consistent with the MSCI Specialist Credit IndexSM, which are funds that invest primarily in fixed income, the MSCI Hedge Fund Fixed Income IndexSM returned 0.10% in July bringing its year to date return to 10.53%. In contrast, the MSCI Sovereign Debt Index declined by -2.97%. The MSCI Global High Yield Corporate Index fell -0.59% in July while the MSCI U.S. Treasury Index fell -4.46%.

By geography, funds focusing on Europe fell -0.57% in July on a U.S. Dollar basis, but in Euros, the return was 1.45%. Hedge funds focused on North American markets gained 0.96%. Japanese focused hedge funds outperformed on a U.S. Dollar basis gaining 1.19%, and on a Yen basis, the return was 1.59%. The MSCI Hedge Fund Emerging Market IndexSM gained 1.65% outperforming the MSCI Hedge Fund Developed Market IndexSM, which gained 0.14%. This is consistent with the performance of equities globally as the MSCI Emerging Markets Free IndexSM gained 5.99% while the MSCI World Equity Index returned 1.92%.

The MSCI Hedge Fund Indices are composed of more than 160 indices. More than 1,700 hedge funds have agreed to participate in the database and there are over 1,550 hedge funds currently in the MSCI Hedge Fund Indices and Database.

MSCI defines Directional Trading strategies as those based upon speculating on the direction of market prices of currencies, commodities, equities, and bonds in the futures and cash markets. Relative Value strategies focus on spread relationships between pricing components of financial assets or commodities. Security Selection managers combine long positions and short sales with the aim of benefiting from their ability in selecting investments while offsetting systematic market risks. Specialist Credit funds seek to lend to credit-sensitive issuers. The Multi-Process group comprises funds which practice a strategy whereby a single investment process does not account for more than 80% of their risk capital.
